AUCTION-CUM-BID NOTICE
FOR
SALE OF OFF-ROAD VEHICLES

Sealed tenders are invited for auction of 2 off-road vehicles viz. 1- Indica DLE Car (2003 model) and 1- Auto Rickshaw (2002 model), in the office premises on 'AS IS WHERE IS BASIS' on 14.10.2022 at 1.00 p.m. Sealed tenders/rates may be submitted on or before 07.10.2022 up to 1.00 p.m. as per descriptions of the Vehicles mentioned at Annexure 'A' annexed hereto.

Interested parties for inspection and other details in respect of the said vehicles, if they so desire, may inspect the said vehicles on any working day between 11 a.m. to 4.00 p.m. except holiday for any further information about the said off-road vehicles before quoting the rates.

A. TENDER

1. Two separate sealed envelopes should be used for submitting (i) "Earnest Money" and (ii) "Tender Document", superscribing on the envelopes (a) "Earnest Money for SALE OF OFF-ROAD VEHICLES" and (b) "Tender for SALE OF OFF-ROAD VEHICLES" respectively. Bidder is required to submit separate sealed cover written bids for each of the vehicle(s), they intend to bid for.
2. The tender may be sent by post sufficiently early so as to reach the Registry within time, or may be delivered to the undersigned. If tender is sent through Messenger, an authority letter from the tenderer with proof of identity may also be given to the Messenger so that he could show the same along with his own identity proof to the Reception counter of Planning Department for issuance of Entry Pass.
3. The tenderer is expected to examine all the instructions, Proforma's terms & conditions and specifications in the tender documents. Failing to furnish all information required by the tender document in any respect will be at the tenderer's risk and may result in the rejection of the tender.
4. The tender must be received not later than the date & time specified for submitting the same. In case, the date of submitting the tender will be declared as holiday by the State Government then next working day will be treated as due date of tender.

B. TERMS AND CONDITIONS OF BID

5. The auction of all the vehicles will be held one by one, and not as a single lot. The bid will be confirmed in favour of the person offering the highest bid in respect of that vehicle. The auction will be held in the office premises of Planning Department, Babupara, Imphal.
6. Only those bidders shall be eligible for bidding in the auction, who deposit refundable amount by way of "Demand Draft/D-at-Call as Earnest Money" as per details mentioned in Annexure-A attached herewith for the vehicle(s), they are opting for or bidding for which is drawn in favour of "Deputy Director, Secretariat: Planning Department" account of DDO(Planning) from a nationalized bank which will be refunded to the unsuccessful bidder on their written request with respect thereto. Name of the firm/individual, telephone no. and address may be indicated on the reverse side of the Demand Draft/D-at-Call.
