State Level Nodal Agency for Watershed Management - SLNA (WM), Manipur invites tender (two bids system) from registered firms/ individual vendors for purchase of the Hampshire breed piglets under Pradhan Mantri Krishi Sinchayee Yojna – Watershed Development Component 2.0 (PMKSY – WDC 2.0) as per the specification given below:

**1. General Conditions:**

- Institution/Firm(s)/ individual Vendor etc having registered GST with experience of supplying Hampshire breed piglets business may apply for the tender.
- Supply shall be as per specification mentioned in the tender.
- The purchased livestock must be delivered to DC/PIA Office of Imphal West, Imphal East and Kakching, districts.
- Supply of Hampshire breed piglets should be supported by a declaration certificate from a Veterinary Practitioner, breed, age body weight, health status recorded by a subject specialist and duly authenticated at the time of supply. The Veterinarian at the receipt point, on physical examination, has full right to reject any item which is not in conformation with the technical speciation and the supplier has to take it back immediately at his/ her own cost and responsibility.
- Supply of piglets shall comprise with detailed health status, de worming and vaccination record, etc duly certified by a Registered Veterinary Practitioner at the time and point of supply. The origin farm should be free from African swine Flu (ASF).
- Bidder will have to facilitate arrangement of feeds / fodder along with water at the delivery point till the supply is completed and received by SLNA/ District Officer.

- g) All the laws related to transport etc. should be followed as per the Rules under Animal Welfare and guidelines issued by Government of India / Manipur.
- h) Livestock items will be kept under custody and total responsibility of the supplier before acceptance by the authority.
- i) If any livestock is detected defying specification /diseased / unfit at the time of supply, the supplier has to immediately remove such animal(s) from the delivery point at his / her own cost.
- j) Any livestock not fulfilling the technical specification at the time of delivery, acceptance will be rejected and the bidder will have to take back such animal(s) at his / her own cost without raising any question / objection.
- k) All bids must be accompanied by Earnest Money Deposit (EMD) as specified in the bid document and must be furnished with the bid.
- l) **Quantity may be increased or decreased as per actual requirement and decision of the SLNA shall be treated as final.**
- m) At any time prior to the date of submission of bid, the authority inviting tender may, for any reason, whether at his own initiatives or in response to a clarification from a prospective bidder, modify the bidding documents by an amendment. All prospective bidders who have received the bidding document will be notified of the amendment in writing and the amendment shall be binding on them. In order to provide reasonable time to take the amendment into account in preparing the bid, the authority inviting tender, may at his discretion, extend the date and time for submission of bids.
- n) The bid and all correspondence and documents shall be in the English language.
- o) SLNA (WM) reserves the right to reject any or all tenders and shall not be bound to assign any reasons for such rejection.

## 2. Technical Criteria for supply of Hampshire breed piglets:

- a. Institution/Firm(s)/ individual Vendor etc having registered GST with experience of supplying Hampshire breed piglets business may apply for the tender.
- b. Proof of Financial status in the form of balance sheet / ITR of the firm/ Vendor in regard to the business for the Assessment Year 2021-22 and 2022-23.
- c. Agency should have successfully completed similar contract in supplying Hampshire breed piglets to reputed government or non-government agencies.
- d. Firm/vendor should not be a banned/ backlisted/ temporarily suspended by any /Government / Department / Organisation firm/vendor at any cost.
- e. Declaration certificate from a Veterinary Practitioner, breed, age body weight, health status recorded by a subject specialist, wherever applicable.
- f. Health status, de worming and vaccination record, etc of the supplying piglet duly certified by a Registered Veterinary Practitioner and declaration for free from ASF.

## 3. Earnest Money Deposit:

- All bids must be accompanied by **EARNEST MONEY DEPOSIT** of an amount of **Rs 6,000/-** (Rupees Six thousand) in the form of Demand Draft/Bankers Cheque in favour of "**Chief Executive Officer, State Level Nodal Agency for Watershed Management SLNA (WM), Manipur**". EMD submitted in any other form or bids without EMD shall not be accepted. The EMD of the successful bidder shall be retained till completion of the tender period but shall not carry any interest. The EMD of the unsuccessful bidders will be returned within 30 days after the finalization of the tender.

## 4. Security Deposit:

L1 Bidder shall deposit a Security Deposit of 5% of the L1 value at the time of signing agreement, which will be refunded after 1 month of the successful delivery of the item. It shall not carry any interest.

## 5. Financial Bid:

- Bidder shall quote the rate including Transportation cost (as one unit) and applicable GST, wherever applicable.
- The bidder shall quote the rates both in figure and word.
- The rates once offered must remain fixed and should not be change for whatsoever reason during the contract period.

## 6. Technical proposal and content:

- Covering letter.
- General information about the bidder.
- EMD in the form of Demand Draft.
- Duly attested copy of Valid Registration certificate /Trade license certificate for doing such business.
- Copy of PAN card.
- Details of similar supply assignment done in the past and financial status to be supported by document, if any. Otherwise, a NIL declaration in this respect is to be submitted.
- Technical specification of the animals as specified above duly signed by the bidder and certified by a registered Veterinary Practitioner / Competent Authority should be produced.
- A copy of certificate on disease free status regarding all livestock from a registered Veterinary Practitioner/Competent authority against each consignment of supply is to be produced, whenever if applicable.
- Income Tax Return for the Assessment year 2021-22 & 2022-23 covering item listed business, if any.
- Self-declaration certificate of Non-blacklisting / Non banning / Temporary suspension by any Government Department / Organizations.
- An undertaking stating that if the information / declaration / scanned documents furnished in respect of eligibility criteria are found to be wrong or misleading at any stage, the bidder will be liable to punitive action with immediate cancellation.
- CEO/SLNA may ask to physically produce any of the certificates in original for verification, if needed.

## 8. Validity of Bids

Bids shall remain valid for acceptance for a period of 90 days after opening of Technical bid i.e. Technical bids with shorter validity shall be rejected. Purchaser may solicit bidders' consent to an extension of bid Validity period. A bidder may refuse extension request without forfeiting the bid Security.

## 9. Validity of tender

The validity of tender of the successful bidder shall be at least 1 year from the date of finalization of the order and the successful bidder(s) are bound to supply the items at agreed rates during this period. This validity period may be further extended with mutual consent.

**10. Tender Evaluation:**

- Both the bids should be submitted in sealed cover separately. NIT number of the technical and financial bids should be superscribed on the respective sealed covers in order to clearly identify the two bids.
- The technical bids submitted by the bidders will be evaluated by concerned technical committee and the technically qualified bidders can only participate in the Financial Bid.
- For technical evaluation, concerned technical & scrutiny committee will examine the eligibility of the bidder as per the technical bid documents notified in the tender. Bids of the bidder not satisfying the eligibility criteria and any technical deviation / non submission of any of the documents mentioned above, will be straightway rejected by the committee.
- All the financial bids shall then be ranked according to the financial bid in increasing order. (The bidder quoting least amount, as rank L1 and quoting next higher figure as LZ and so on).
- L1 will be declared as successful bidder and his offer will be processed further.
- However, SLNA (WM) reserves the right to offer the contract to the L2 and L3 Bidders as well, if there is any non-compliance of timely supply by the L1 bidder evaluated through the Technical and Financial bids.

**11. Mode of submission:**

- The Sealed tender shall be submitted by registered post or speed post or by depositing the tender form in the drop box of the office of CEO, SLNA (WM), Manipur, Planning Department Office, Babupara, Imphal 795 001 on or before 04:10 PM of 30.11.2023. Tender received after aforesaid date, time and received in any other mode shall be rejected. The CEO, SLNA (WM), Manipur shall not be responsible for any kind of delay.

**12. Payment to the Agency:**

- Payment will be made by PFMS mode within 15 days on submission of invoice to CEO, SLNA(WM) after successful delivery of the consignment to District/ SLNA.
- Applicable GST (TDS) will be deducted by Planning Department.

**13. Agreement:**

The successful tenderer shall execute an agreement on non-judicial stamp paper of value of Rs.100/- (stamp duty to be paid by the tenderer) within 15 days from the date of the intimation from Tender Inviting Authority informing that his tender has been accepted.

**14. Adjudication/ Review Borad:**

Any dispute arising out of or during execution of the contract shall be settled with mutual agreement through an Adjudication/Review Board appointed by the appropriate authority of the purchasing organization.

**15. Saving Clause:**

No suit, prosecution or any legal proceedings shall lie against Tender Inviting Authority or any person for anything that is done in good faith or intended to be done in pursuance of tender.

**16. LAWS GOVERNING THE CONTRACT & JURISDICTION:**

The contract shall be governed by the laws in force in India. In the event of any dispute arising out of the tender such dispute would be subject to the jurisdiction of the Civil Court within the city of Imphal only.
