State Government has been requested to prepare the draft Annual Plan 2010-11 proposals and submit to Planning Commission **within 30<sup>th</sup> November, 2009.**

2. As per the stipulations of the Planning Commission, **the plan proposals for 2010-11 are to be prepared assuming an increase of 10% over the Central Assistance provided in 2009-10.** The schedule for the finalisation of Annual Plan 2010-11 for the States indicated by the Planning Commission are as given below:

- iii) Outlines of Annual Plan 2010-11 proposals including all earmarked programmes and separate paragraphs on:

- a) Schedule Caste Special Plan (SCSP),
- b) Tribal sub Plan (TSP),
- c) District Plan,
- d) Special Plan Assistance, if any,
- e) EAP, if any,
- f) Women component, if any,
- g) Voluntary Sector, if any,
- h) Initiative for additional resource mobilization, if applicable,
- i) Reform Programme undertaken, if applicable.

4. In view of the urgency of the matter, you are requested to expedite preparation of draft Plan Proposals for Annual Plan, 2010-11 in respect of your department and **submit five (five) copies of draft Plan proposals to Planning Department latest by 20<sup>th</sup> November, 2009 positively along with soft copy (write up portion in MS-Word and Statements in MS-Excel). Formats** for preparation of Statements **are yet be sent by Planning Commission**. The same will be made available as soon as these are received from the Planning Commission.
