Minutes of meeting of State Level Committee on SEGP held by Shri D.S. Poonia, Chief Secretary (Planning), Manipur on 22.3.2010 to discuss issues relating to assisting of the fire victims in Wino Bazar under Special Employment Generation Programme (SEGP).

The following members were present:

2. At the outset, Chief Secretary, Manipur referred to the reference from His Excellency the Governor of Manipur for assisting the victims of the devastating fire incident on 9 March, 2009 at Wino Bazar, Ukhrul. Several houses/shops were gutted and properties worth about six and half crore of rupees was destroyed. He expressed concern over the delay in submission of an incomplete proposal by the MSCB.

3. Shri T. Ranjit Singh, MD/MSCB explained that out of the list of 47 persons forwarded by the DC/Ukhrul, only 7 applicants have been found eligible as per SEGP guideline. The remaining 40 applicants have not been found eligible. He requested DC/Ukhrul to send the balance 60 applications for their examination.

4. Shri Ashok Kumar, DC/Ukhrul stated that all the applicants forwarded to MSCB are fire victims and need to be assisted under SEGP, if necessary by relaxing the guidelines.

5. After detailed discussion the following decision were taken;

- i) Approved the list of 7 applicants recommended by MSCB for assisting under SEGP.
- ii) Wino Bazar fire victims may be assisted under SEGP by devising viable schemes below Rs. one lakh each so that there may not be any need for security collateral. MSCB & DC/UKL to re-examine jointly and send recommendation to **Plg Deptt within 20.04.2010.**

- iii) DC/UKL to expedite and recommend the balance 60 applications **to MSCB on similar lines within 15.04.2010.**
- iv) If MSCB is unable to accommodate these 100 cases, the SEGP funds available with them be refunded to the Plg Deptt. **within 30.04.2010.**

2. The meeting ended with a vote of thanks.


