**Minutes of Meeting of the State Level Committee (SLC) on Special Employment Generation Programme (SEGP) chaired by Shri D.S. Poonia, IAS, Chief Secretary, Manipur held on 2<sup>nd</sup> May, 2011 to consider cases of 14 fire victims of Wino Bazar, Ukhrul under SEGP.**

**The following members were present:**

- ii) Shri Ashok Kumar, DC/Ukhrul
- iii) Shri T. Ranjit Singh, MD/MSCB
- iv) Shri Y. Indramani Singh, Joint Director/Plg Deptt

2. Chief Secretary, Manipur welcomed all the members present in the meeting and asked MD/MSCB to briefly highlight the main agenda of the meeting, and details of the proposals.

3. MD/MSCB explained that the meeting had been convened primarily for consideration of 14 applications submitted by DC/Ukhrul for assisting the fire victims in Wino Bazar under SEGP, which entails the financial implication of Rs.25.376 lakh. He stated that 95 fire victims had already been assisted under SEGP involving Rs.156.52 lakh. With this, the total number of fire victims being assisted under SEGP, will come to 109.

4. Chief Secretary wanted to know if there are still some more applications of fire victims to be submitted by DC/Ukhrul to MSCB for financial assistance under SEGP.

5. DC/Ukhrul clarified that no other application is left now in his office for forwarding to MSCB for assisting under SEGP among the fire victims of Wino Bazar. Hence, this case can be considered a close chapter.

6. MD/MSCB stated that all 14 loan applications submitted by the Deputy Commissioner, Ukhrul had been forwarded to SLC for consideration after making proper appraisal of each application.

7. Thereafter, SLC had examined all 14 cases along with trade recommended by the MSCB, vis-à-vis fund availability.

8. After discussions, the following decisions were taken:

- i) Approved the list of 14 applications recommended by MSCB for assisting the fire victims of Wino Bazar, Ukhrul under SEGP

- .ii) Disbursement of loan to be completed early by MSCB in consultation with DC concerned.
- iii) The point of loan recovery of loan principal and interest was noted. MD/MSCB was asked to take action for enhancing loan recovery.

10. The meeting ended with a vote of thanks to the chair.
