

**GOVERNMENT OF MANIPUR

Record of inspection visit to check out SPA, NLCPR, and NEC works in Tamenglong district, led by Dr. Sajjad Hassan, Special Secretary, Planning, Govt of Manipur (5-6 May, 2011)

1. List of officers in attendance is annexed. The absence of any responsible officer from PWD was noted with regret. Only an AE was available to the visiting team. Considering that most works under SPA in the district fell within the purview of PWD, this hampered effective information sharing and discussions.
2. The Team visited the following important projects taken up in Tamenglong District with funding from SPA, and during the visit, the team were accompanied by DC, SDOs, ADC and other officials of the district administration.. A Statement indicating the status of implementation and observation made by the team is as given below:

3. Towards the end of the visit, Special Secretary (Plg) held a wrap-up meeting in the conference of DC office with DC, Tamenglong, DLO and other officials accompanying the team. The following observations were made.
- i. General lack of awareness with District Administration on projects/schemes taken up in the district. This prevents any support from District Admn in coordinating and supervision of works for timely completion.
 - ii. The sorry state of upkeep of Khongsang-Tamenglong road was noted. DC and DLOs urged intervention of State Government for upkeep of this road, and that continuing to Tamei. Issue of taking up of work on Tamenglong - Tousem – Haflong road was also raised, and requests made to take up the matter with State Government/NEC.

- iii. Poor facilities at Dist Hospital: No ambulance, poor power availability hampering working of equipment, and no specialists. The OT Room, constructed by DRDA under RSVY, had not been handed over, because as per DC TML, supplies of equipment, were not completed. DC was advised to sort out the matter quickly, and DD Health department requested to take up the issue of Ambulance, Solar power support, and specialist doctors, with higher authorities.
 - iv. General tardy working of SSA programme, with late supply of textbooks, and of funds. Education indicators in Tousem block especially were a matter of concern. The KGBV at Mandu village was the only effective working facility, but this was facing serious infrastructure hurdles.
 - v. The problem of water supply throughout the district, and of depleting water sources was discussed. Rainwater harvesting as alternative and sustainable method was proposed for taking up by PHED, as under schemes of innovation.
 - vi. Lack of Science teaching at the lone college in the district was raised. DC/TML was advised to send proposal for the inclusion of Tamenglong Govt college for funding under SCA for upgradation of infrastructure and also for opening science stream with copy to Plg Deptt..
4. Special Secretary Planning urged ED DRDA and BDOs to involve communities in social audits of NREGA work, and of using BRGF resources for gap filling, and innovation projects.
 5. DC TML was advised to hold monthly meetings of District 20 PP Committee, review implementation of works and submit reports to Planning Department for onward submission to GoI. DC and ED DRDA were also asked to activate the Tamenglong district website for hosting information about Central and state schemes being implemented for the convenience of the general public.

Meeting closed with SS Planning thanking DC and DLOs TML for making the inspection tour to Tamenglong possible, and to the participating departments and officers for their support.
