

ORDERS BY THE GOVERNOR : MANIPUR
Imphal, the 30th March 2012

- No. 4/8/2011-12/BADP/Plg (Pt.I) :The Governor of Manipur is pleased to accord Administrative approval and expenditure sanction to an amount not exceeding **Rs. 939.68 lakhs (Rupees nine hundred thirty nine lakhs & sixty eight thousand)** only as 2nd installment for Implementation of works under BADP as grant-in-aid for the year 2011-2012.
2. The expenditure is debitable under Demand No. 30 – General Economic Services and Planning; Major Head – 3451 – Secretariat Economic Services (Plan) Sub-Major –00, Minor - 092 – Other Offices Sub – Head – 01-Border Area Development Programme. Detailed – 00, Object - 35 – Grant for Creation of Capital Assets for the year 2011-2012.(R.E)
3. The Scheme-wise amount to be released to the executing agencies is indicated as Annexure-I,II,III & IV.
- 4 The amount of Rs. 77.87 lakhs for the scheme Mobile Health Dispensary/Ambulance Services at Remote Border Village shall be Deposited to Major Head 8449-Other Deposits (Public Account.)
5. The execution of work will be done through the Executive Director, DRDA Churachandpur, Ukhrul, Chandel and I.G. Assam Rifle (South). The executing agencies will submit quarterly progress report both physical & financial and utilization certificates with necessary vouchers to the Planning Department Manipur for audit purpose in time.
6. As per terms of the Finance Department, Administrative Department shall deduct at source; Sales tax and 1% cess for Labour welfare. No Agency Charge is levied under BADP Scheme to be implemented by Autonomous District Council through Village Authority and works to be implemented through Assam Rifles.
7. This issues with the concurrence of the Finance Department vide their **U.O.No.3/2011-12/ FD(30-P/ 75) Plan dated 30.3.2012.**
8. The sanctioned amount would be drawn and disbursed by the Deputy Director, Planning Government of Manipur.
